In the National Legal Services Authority v. Union of India case from 2014, the Supreme Court of India established the precedent for the rights of transgender people in India by acknowledging "transgender" as a "3rd gender" and establishing a number of rules to prevent discrimination against transgender people and protect their rights. In November 2015, Kerala have become the first state in India to formulate and launch a transgender policy in a bid to quit the injustice against this "third gender" network. It includes a plethora of progressive steps for the recognition, inclusion, and empowerment of the community, together with trans men, trans women, and intersex individuals in financial and social possibilities, public transport, health, social protection, education, and career sectors, thus setting a robust instance throughout India and overseas.

HISTORICAL EVOLUTION OF TRANSGENDER COMMUNITY IN INDIA

Transgender has been an integral part of Indian society. The historical evidence for recognition of Transgender Community can be traced back from Vedic Literature and Puranas. The stories of Transgender has been mentioned in India's greatest epics such as the Mahabharata and the Ramayana. In the Medieval history, especially in Mughal period Transgender enjoyed special status. Later in Colonial period the British officials criminalized and denied their rights. These led to drastic change of position and situation of Transgender. In contemporary India, Transgender are considered as weak and marginalized section of the society. Indian government launched many policies and schemes for

the welfare of Transgender Community. The government also passed Transgender bill so they enjoy their Fundamental Rights.

First private member's bill approved by the Rajya Sabha in 36 years and by the entire Parliament in 45 years was the Rights of Transgender Persons Bill of 2014. The state of Kerala has end up the first state in India to roll out a transgender policy in 2015 toward ending societal stigma attached to this sexual minority group.

STATEMENT OF THE PROBLEM

Kerala become the first state to introduce transgender policy and many new schemes were introduced by the state for the development of transgender people. This paper addresses that is this schemes are beneficial for Transgender community and what improvement are they expecting from Kerala state government.

Finding the various factors responsible for the benefit of Kerala's transgender schemes is the nature of the challenge. The development of the transgender community in Kerala will be the central focus of the problem's scope.

The Indian government has recently adopted new policies and programmes for the transgender community's social protection and wellbeing.

G Reshmi and K S Anil Kumar in the name 'Transgender: charithram samskaram prathinidhanam' about the realities of transgenders who are preparing to build a history lesson of survival by overcoming crises of the community.

Aneesh MS in his paper targeted on the high-quality of life among male to female transgenders in Kerala who were between age group of 18-40. The study adopted a descriptive research methodology and utilized quantitative methods. The study population consisted of male to female transgender people aged 18 to 40 from the three districts (Kottayam, Ernakulam, and Thrissur) of Kerala, India.

Neena Sawant in her paper 'Transgender: Status in India' in this report she explains the historical background as well the new policy adopted by government of India. She try to explain the important of Transgender community in India.

Jisha Chakkunny M and Sundara Raj T in 'Problems and Possibilities of Transgender Entrepreneurship in Kerala explained the major constraints confronted by the transgender entrepreneurs. Transgender entrepreneur enjoys high status and positions in our society. but transgender entrepreneurs face multiple varieties of issues and challenges. It

negatively influences their efficiency. So this paper give suggestions for the development of transgender entrepreneurship.


RESEACH METHODOLOGY


DATA ANALYSIS


What sex were you assigned at birth, on your original birth certificate? 50 responses



What is your current gender identity? 50 responses




what is your current partnership status?




What are your current living arrangements? I live...







RESULTS AND FINDINGS

When asked from the transgender community from Kerala about the schemes initiated by Kerala government for the upliftment of transgender community, mostly 80% are aware about the schemes 20% are not even aware, According to the questionnaire, lack of communication between the community and government was the main reason for not knowing about the schemes. But 90% responders told they got advantage from scheme which provide Rs. 30,000 for legally married transgender couples who have underwent Sex Reassignment Surgery (SRS) and scheme which provides financial assistance to scheme for transgender persons for undergoing sex reassignment surgery. The maximum amount of financial assistance will be up to Rs. 2 lakh. Other schemes which focuses on education and employment generation, they are not much aware about the schemes.

RECOMMENDATIONS

The following suggestions are made for the development of Transgender community in Kerala.

• Make them aware about the schemes

Mostly, people from transgender community are not known about different schemes initiated by the government of Kerala. It may be lack of communication between the government and the community. The community is only aware about some certain schemes. But the government of Kerala had initiated schemes for the development of education , health care and employment generation. If they are not aware about all those schemes the fund will be misused by the government employees.

• To include Trans persons in policy drafting

Another recommendation is that the government have to include transgender person in any policy drafting process that deals with the development of their community. So the government can easily draft policy according to the actual need of the community. It can also help to make them aware the new schemes, it will lead to the upliftment of the community in mainstream society.

- Increase the amount for Sex Reassignment Surgery (SRS) or Free Surgery facility
 The government is providing minimum amount of 2 lakh as financial assistance for Trans Person who underwent SRS. But in private hospitals SRS(male to female surgery) can normally costs between Rs 2 lakh to Rs 5 lakh and SRS (female to male surgery) can costs between 4 lakh to 8 lakh. 56% of trans people are self employed and they stay away from family so neither have a stable income not support from their families. So they are demanding to increase the surgery amount or free surgery facility in government hospitals.
- Sanction SRS money without any delay

The state government of Kerala is providing Sex Reassignment Surgery (SRS) for transgender person who underwent surgery. But there is delay in sanctioning the amount. So another suggestion is to provide amount directly to the person without any delay.

CONCLUSION

In Kerala, the transgender community is vulnerable and subject to discrimination. They experience violence and discrimination in every aspect of their daily lives from members of the majority culture. The state of Kerala launched several schemes to support the transgender community. The topic of the current study is the state of transgender policies in Kerala at the moment. Another reason this study is helpful for the community is because there has never been a study done in Kerala that looks at the advantages of transgender policies. This study aids in examining existing understanding of the schemes and aids in helping people learn more about the government-initiated programs.
