**Abstract:** 

Business Incubators are very much popular in today's world which promises to provide

help and support to the intended entrepreneurs and innovators. The term business incubator refers

to a physical or virtual setup comprising of facilities which are key for a new business to start and

to grow. One of the most important social issues in Assam is unemployment. The problem of

unemployment arises because of some serious factors like lack of industry, lack of proper

expertise and knowledge, inadequate market place, lack of proper source of seed capital for small

businesses etc. In the meantime, some of the young educated are trying to start their own business

but they are not very successful only because of lack of proper business idea or substandard

execution of a good idea.

A study was carried out to focus on understanding the current startup ecosystem of the

state of Assam and to prepare a blueprint of the current scenario. During the study it revealed that

new initiatives of Government of Assam, by way of establishing business incubator, aided the

startups in various aspects including funding, mentorship, physical facilities etc. These initiatives

significantly boosted the startup ecosystem which is evident from the studies of the new 12

startups indicated in the results and discussion section.

Assam is located in the northeast of India. The state shares its borders with Arunachal

Some of the other industries of the state are Fisheries, Sericulture, Forest and wood industry, Chemicals and fertilizers industry etc. Assam is one of the major producers of crude oil and natural gas in India. There is a lot of demand and scope for the traditional handloom and handicraft items of Assam and thus the traditional artisans should be nurtured. Sadly, these incredibly skilled people are often amongst the unemployed and poorest of the poor because they are trapped in inefficient markets and exploitative supply chains without access to capital, lack of design inputs and ready markets. As a result, they lose out to cheap, mass-produced goods and their children discard millennia-old traditions and migrate to cities for a living. There is a growing demand for sustainably produced goods which are handcrafted with unique and contemporary designs which comes with an emotional story.

Entrepreneurship is a buzz in today's world which has lots of opportunities to offer. The current global trend reflects the impact of entrepreneurial initiatives on the world economy. India as a country has seen a huge improvement in the society towards entrepreneurship development in the past decade. Even the current government's drive towards entrepreneurship development has given rise to a plethora of entrepreneurial opportunities that only needs to be identified and take hold of. According to a recent World Bank report, India has significantly improved its global ranking in ease of doing business in 2016. This is indicative of the entrepreneurial frame of mind that is being stirred in the society and the assistance towards it from the government. As per the India Entrepreneurship Report 2015 by Amway, only 22% of respondents in Assam felt that the business environment in the state has improved significantly.

# **Methodology:**

The study was based on the current startup ecosystem therefore it included extensive study of available resources from secondary sources to help understand the history and evolution. Extensive survey work was carried out throughout the town and city areas of Assam including village market areas. The primary data were collected through Survey and questionnaire wherein surveys helped in understanding the current situation and questionnaire helped in understanding the need which was not addressed. The services offered by the different business incubators were assessed and mapped with the requirements of the startups being incubated in the incubator as well as the startups who have already graduated from them.

The study was conducted among the 18 budding entrepreneurs of Assam and they were interviewed, 16 were male and 2 female. The age of the entrepreneurs was between 25-58 years. The business incubators which supported the startups under the study are Assam Start Up – The Nest which is an initiative of the Assam Government and down town Venture Labs which is a private initiative of Assam down town University set up for the startup ventures which seeks to augment the business environment by promoting idea generation to startup companies and help them establish and accelerate their growth and success.
